Art. 1

Art. 3

The Prize will be awarded by a Commission composed as followed:

- The President of the Scientific Committee of the Laboratory of Research on "Creative and Sustainable City";
- The Director of the of Laboratory of Research on "Creative and Sustainable City";
- A representative of the Scientific Board of the Interdepartmental Centre of Research on Urban Planning "Alberto Calza Bini";
- A representative of Scientific Board of the PhD on "Evaluation methods for the integrated conservation, renewal, maintenance and management of the architectural, urban and environmental heritage";
- Two representatives of the World Urban Campaign UN Habitat Steering Committee.
- A representative of UN-Habitat-Universities

Art. 4

The Commission will award the Prize to the candidate who will have developed a work both original and consistent with the research topic indicated at the previous art.1. The Commission's judgment is indisputable

In case of *ex aequo*, the Prize will be awarded to the younger PhD doctor; in case of *ex aequo* between two or more PhD doctors with the same age, the Prize will be divided in equal parts between the PhD doctors eligible to the Prize.

In case none of the dissertations presented matches the expected performances, the Commission will not award the Prize. In this case the Prize will be possibly awarded on the following year.

Art. 5
