

The application forms should be completed electronically, printed out and submitted to us by the International Offices of the sending institutions.

Application for Admission (Antrag auf Zulassung zum Zeitstudium)

Note: Every student will receive additional information with the "Letter of Admission".

Application for Housing (Antrag auf Aufnahme in ein Studentenwohnheim)

Note: Early booking and transfer of deposit is of utmost importance, otherwise we cannot guarantee student dorm accommodation to your students! The housing office observes strict closing dates for reservations. The application and the deposit must have been received by June 15 for the "winter semester" and by January 15 for the "summer semester".

For students from outside the European Union, the European Economic Area or Switzerland:

# Proof of Financial Resources (Finanzierung-snachweis)

All international students who are not citizens of the European Union, the European Economic Area or Switzerland require a student residence permit for the duration of their period of study at a German university, which is issued by the local Office of Foreigners' Affairs at the place of study in Germany. In order to obtain this permit, students must prove that they have sufficient financial support to cover their living costs during their study period in Germany ("Finanzierungsnachweis"). The proof must be presented upon arrival in Konstanz. Detailed information will be sent with the "Letter of Admission".

# 2. Orientation Program / Language Courses: Pre-semester Programs

The orientation period is designed to help new international students go through the formalities of matriculation etc. It is obligatory for all new exchange students and highly recommended for all other newcomers.

Participation is only possible in one of the following programs:

 September Intensive Language Course 2011 with Orientation Program (4 weeks)

The course will run from September 5 – September 30, 2011. Date of arrival is September 1 or 2, closing date for applications: July 31, 2011.

October Orientation Program 2011

This program will run from October 6 – October 9, 2011.

Date of arrival is October 4 or 5, closing date for applications: July 31, 2011.

Classes in the winter semester 2011/12 will start October 17, 2011.

March Intensive Language Course 2012 with Orientation Program (4 weeks)

The course will run from March 5 – March 30, 2012. Dates of arrival are March 1 or 2, closing date for applications: January 31, 2012.

April Orientation Program 2012

This program will take place on April 4/5 and April 10, 2012. Date of arrival is April 2 or 3, closing date for applications: February 28, 2012. Classes in the summer semester 2012 will start April 16, 2012.

Your students will receive the course descriptions and application forms for the pre-semester programs along with their "Letter of Admission".



#### 3. Course Information

Exchange students should be fluent (B1/B2 level according to European reference frame) in EITHER German OR English in order to successfully complete a full course load during their exchange studies at the University of Konstanz.

#### Classes taught in English and Intensive German Training

Although the language of instruction at the University of Konstanz is German, there are many departments which offer a great variety of courses in English. Exchange students with elementary German language skills can combine Intensive German language courses taught at the University of Konstanz' Language Institute with courses taught in English at the respective departments. 



   Please pay the deposit (450 EUR) in advance by June, 15 for the Winter Semester, or respectively January, 15 (for the Summer Semester), otherwise a reservation cannot be made.

An administration fee of 50 Euros will be deducted from your deposit; you will be reimbursed 400 Euros when you move out of student residences.

Are you planning to participate in one of our pre-semester language courses?
 If so, please make sure that the rental period indicated on your housing application coincides with the beginning of the language course.

We will pass on your application forms to the offices in charge of housing (Seezeit) and Admissions. The respective offices will issue the Confirmation of Housing (only if you have transferred the deposit of 450 EUR), the Letter of Admission and the Confirmation for the Language Course and send those documents to you or your home institution directly.

Please also note our information on **Health insurance requirements** attached below.

#### Non-EU/EEA/Swiss citizens please also note:

In order to apply for your German residence permit upon arrival, you will need **proof of Financial Resources** (**Finanzierungsnachweis**) of at least 660 EUR/month. Please find detailed information attached in a separate document.

#### **Health Insurance Information (Please read carefully!)**

During a stay in Germany, all international students must, **as an absolute requirement**, have a health insurance policy that is valid for the whole of their stay in Germany. The Immigration Authorities require you to prove that you are adequately health insured before they can issue a residence permit. Please note that you must have health insurance from your **very first day in Germany**.

Such a health insurance policy must at least provide the following cover: medical treatment for acute illnesses/diseases and accidents in Germany as well as the costs of medical (doctor) and hospital treatment (minimum coverage 100.000€). Depending on your age and nationality, various options are open in respect of health insurance policies:

- 1) You are an **EU citizen**: The Member States of the European Union introduced the European Health Insurance Card (EHIC) in 2004. It is issued by the national insurance carriers in your home country. Students from EU/EEA countries and Switzerland can present the European Health Insurance Card (EHIC) or a substitute certification to a German statutory health insurance company upon arrival and receive a confirmation of freedom to choose a health insurance fund. As a holder of a European Health Insurance Card, you can contact doctors and hospitals directly in the case of illness or disease, in all EU Member States.
- 2) **Students from non-EU countries** we STRONGLY recommend to take out a German health insurance.
- → Students **under 30 years of age** can register with a German statutory health insurance company for ca. EUR 70 per month. When students present their chip card at the doctor's, the treatment costs are invoiced directly between the doctor and the health insurance company. Please note that there is an additional, quarterly administration fee of 10€ to be paid for doctor's visits.

You will be able to take out German statutory health insurance only upon arrival in Konstanz. Please make sure to have additional travel insurance to cover you for the first days of your stay in Germany.

→ Students **who have reached their 30th birthday** will want to take out a private German health insurance. In this case, the costs for treatment must first be paid by students themselves and the receipt must then be submitted to the health insurance company.

#### 3) Exemption from Compulsory German Health Insurance

International students can also present a confirmation to a German statutory health insurance company that they have taken out private travel insurance for their entire stay in Germany in their home country, and are therefore sufficiently insured according to German standards and for the entire duration of their stay in Konstanz (proof of coverage with a German or English translation required). These students receive a confirmation of exemption from the insurance obligation. This exemption applies for the whole duration of study in Germany and it is **not possible** to change later to a German statutory health insurance company. In the case of illness, students are required to pay for all (often very high) costs themselves and then must apply to their health insurance company in their home country for reimbursement of the costs. As the travel insurances generally only cover costs to the level of the home country rates and these rates are often much lower than in Germany, students have to pay the additional costs. On top of that, some international insurance companies exclude certain treatments from their coverage entirely.

Therefore - PLEASE NOTE THAT WE STRONGLY DISCOURAGE YOU TO CHOOSE THIS THIRD OPTION!

#### **Finanzierungsnachweis**

Alle ausländischen Studierenden, die nicht Bürger der EU, der EWR oder der Schweiz sind, benötigen für die Dauer ihres Studienaufenthaltes an einer deutschen Hochschule eine Aufenthaltserlaubnis zu Studienzwecken, die von der örtlichen Ausländerbehörde am deutschen Wohnort erteilt wird. Für die Aufenthaltserlaubnis müssen Studierende nachweisen, dass sie über **ausreichende Finanzmittel** zur Deckung der Lebenshaltungskosten für die Studienzeit in Deutschland verfügen ("Finanzierungsnachweis"). Hierfür gilt ein Richtsatz von zur Zeit 660 Euro pro Monat.

#### Als Finanzierungsnachweis gelten:

- 1. **Stipendiennachweis** einer deutschen Stiftung/Hochschule oder aus dem Heimatland. Wenn das Stipendium weniger als 660 EUR beträgt, ist der Restbetrag nachzuweisen.
- 2. **Ein Sperrkonto**, das bei einer Bank in Deutschland eingerichtet wurde, wobei ein bestimmter Betrag gesperrt wird und Sie monatlich nur einen festgesetzten Betrag (Betrag muss 660 € oder mehr sein) abheben dürfen. Die Gültigkeitsdauer der Aufenthaltserlaubnis errechnet sich aus dem gesperrten Betrag (z.B. 6x 660€ = 6 Monate Aufenthaltsgenehmigung). Ein Sperrkonto wird nicht von allen Banken angeboten.
- 3. Eine schriftliche Erklärung zur finanziellen Unterstützung (siehe Vorlage umseitig) von den Eltern, dass sämtliche, während des Studienaufenthalts in Deutschland anfallende Kosten von ihnen übernommen werden. Diese Bescheinigung muss bei der für den Wohnsitz zuständigen Ausländerbehörde (nur für Studenten, die in Konstanz wohnen, ist die Ausländerbehörde Konstanz zuständig) im Original und in deutscher Sprache (oder in beglaubigter Übersetzung) vorgelegt werden. Die Unterschrift muss durch eine Behörde (z.B. Stadtverwaltung, deutsches Konsulat etc.) oder einen Notar beglaubigt und mit einem Dienstsiegel versehen sein. Außerdem müssen Einkommensnachweise der Eltern vorgelegt werden. Es kann das umseitig abgedruckte Formular benutzt werden. Die schriftliche Erklärung der Eltern ist zu ergänzen durch einen ebenfalls beglaubigten Einkommensnachweis der Eltern.
- 4. Eine förmliche Verpflichtung (§ 68 AufenthG) von Verwandten oder Bekannten. Die Verpflichtung ist gegenüber einer Ausländerbehörde oder der deutschen Auslandsvertretung abzugeben. Sie kann für die gesamte Studiendauer abgegeben werden. Die Personen, die sich verpflichten, müssen gegenüber der jeweiligen Behörde nachweisen, dass sie in der Lage sind, diese Verpflichtung auch tatsächlich einzuhalten.

#### **Proof of Financial Resources**

All international students who are not citizens of the European Union, the European Economic Area or Switzerland require a student residence permit for the duration of their period of study at a German university, which is issued by the Local Immigration Office at the place of study in Germany. In order to obtain this permit, students must prove that they have **sufficient financial support** to cover their living costs during their study period in Germany ("Finanzierungsnachweis"). The current monthly minimum is **660 Euro**.

#### As valid proof of financial resources can be used:

- 1. A scholarship confirmation of a German foundation/university or from your home country. If your scholarship grants you less than 660 € per month, you will require proof of financial resources to cover the difference.
- 2. A blocked account, opened at a German bank, in a certain amount wich will be blocked and only withdrawable in fixed monthly rates (this sum must be 660 € or more per month). The period of validity of the residence permit is calculated according to the blocked sum (i.e. 6x660€= Residence Permit for 6 months). Please note: This service is not offered by all banks.
- 3. A written confirmation of financial support from your parents (please see the form overleaf) stating that they will take responsibility for all expenses connected with the study period in Konstanz. This must be a document in the German language (or an official translation into English). It must be certified with an official seal by an authority (e.g. local administration, German Consulate etc.) or by a notary. This document, with signatures in the original (not a fax or a scanned copy), must be presented upon registration in Konstanz. Additionally, a certification that your parents have sufficient funds to finance your stay (e.g. confirmation of the bank, bank statement AND income statement) has to be presented in German or English. Again, this document must also be certified with an official seal by an authority or by a notary.
- **4. A formal written commitment** from relatives or acquaintances (§ 68 of the Residence Act (Aufenthaltsgesetz)). This commitment must be submitted to a Local Immigration Office in Germany or to a German diplomatic mission abroad and it can be submitted for the entire duration of the study period. The persons who commit themselves must prove to the respective authority that they are in a position to maintain this commitment.
